**Subject: Constitution of Committee.**

## ORDER

The department contemplates to import Multi Purpose Merino breed of sheep to overcome the deleterious effects of inbreeding in farms, crept in for last many years, and to boost the output of quality rams from farms for accelerating the genetic upgradation programme, About 250 animals including 80 rams of said breed are expected to arrive by end of this year (Dec 2018/Jan 2019). While making preparations for housing of these animals, the department has shortlisted two departmental farms for the purpose viz SBF Daksum and SBF Goabal. Moreover, a provision of 100 lacs has been kept for strengthening of infrastructure of farm(s) where imported livestock will be kept.

Now in order to ensure the utilization of said amount for strengthening of infrastructure vis-à-vis improvised scientific management of livestock, a committee of following Vety Assistant Surgeons is hereby constituted for working out the requirements for shaping the said farms as feasible stations for imported animals. The members of the committee are:-

The committee will visit both the farms and workout the requirements for strengthening of farm infrastructure in terms of renovation of existing structures (with description of each work) and creation of new structures/facilities after taking due inputs from respective farm managements. The tentative cost must be shown against each work.

The committee will furnish its report to this office within a weeks time positively.
