Subject: Sale of culled animals

ORDER

The department has an availability of more than 300 culled sheep of various farms and field organizations; and contemplates to put these animals for sale on hoof weight basis at a centralized place viz. Zakura Srinagar. In this regard, a nodal team is hereby constituted which will ensure smooth sale of these animals. The members of the team are as:-

- Maintain the farm/organization wise records (sale statements etc) and remit the sale proceeds into the Govt. treasury through Accounts Officer, SHD Kashmir.
- Shall handover copies of the duly signed documents, statements, chalans etc to the concerned field/farm officer for their record and reference.
- Mushtaq Ahmad Bhat (member) is assigned to collect sale proceedings for remittance into Govt. treasury

- All DSHOs and Farm Officers will ensure that the culled livestock (already

sanctioned for sale) is pooled at above mentioned sale point between 16th to 20th August 2018 positively and will arrange sufficient number of departmental personnel for escorting the stock and handing-over the same to designated nodal team. Furthermore DSHOs will keep the said stock available at road side at not more than 3 spots in their respective areas of jurisdiction for lifting to Srinagar through departmental vehicles.

- Store Officer SHD Kashmir will arrange/ensure transportation of animals to designated place (transportation schedule is appended).
- DSHO, Srinagar will make fodder and accommodation available for livestock during the sale period and will provide all logistic support to nodal team and ancillary staff for smooth accomplishment of the activity.
