(i). Whereas, the Public Service Commission vide No. PSC/DR/VAS/2019 dated 05.04.2019 forwarded list of Veterinary Assistant Surgeons with recommendation for their appointment as VAS in the Animal/Sheep Husbandry Department;

(ii). Whereas, appointment order in respect of 197 Veterinary Doctors including Tanveer Ahmad Sofi S/o Abdul Ahad Sofi figuring at serial No. 187 in selection list have been issued vide Government Order No. 59-ASH of 2019 dated 22.04.2019, subject to verification of genuineness of the institution, educational qualification, internship, age certificate, Category Certificates/Physical disability/Permanent Residence Certificates and all other documents under rules. Besides the character/ antecedents by CID.

(iii). Whereas, in the meanwhile the department has received communication No. PSC/DR/VAS/2018 dated 30.05.2019 of Public Service Commission. The contents of which for ready reference are reproduced as under:-

Kindly refer to this office recommendation letter No. PSC/DR/VAS/2019 dated 05.04.2019 which among others S.No. 187 Sh. Tanveer Ahmad Sofi has been recommended under OM/PHC category against the post of Veterinary Assistant Surgeon in Animal Sheep Husbandry Department.


The same candidate has also applied under earlier notification No. 10-PSC (DR-P) of 2018 dated 25.09.2018. However, during the scrutiny of the documents it was observed that the candidate suffer from Post-Polio Residual Paralysis (PPRP) with 45% disability which would have rendered him to perform the duties of Veterinary Assistant Surgeon in terms of Government Order No. 147-SW of 2014 dated 17.06.2014. The candidate represented that he is fit to perform the duties and his case was sent to the Principal Government Medical College, Jammu for ascertaining by the Standing Medical Board, whether the candidate was fit to perform the duties of a veterinary Assistant Surgeon. The Standing Medical Board returned its findings that the candidate was fit and had only suffered 10% disability.

In view of the contradictions of two medical certificates, no decision as yet had been taken by the Commission to recommend the candidate under OM/PHC category with respect to the selections made under Notification No. 10-PSC(DR-P) of 2018 dated 25.09.2018. However, while making recommendations vide aforesaid No. inadvertently the name of the said candidate has been recommended to the Government under PHC category for appointment.

It may be pertinent to mention here that the Commission had referred his case to the Standing Medical Board, Government Medical College Srinagar for review of two Contradictory Medical Certificates. Till such time the findings of the Standing Medical Board GMC Srinagar are received, the appointment order of Mr. Tanveer Ahmd Sofi figuring at S.No. 187 in the aforesaid recommendation may be put on hold.

(iv). Whereas, the Public Service Commission vide communication No. PSC/DR/VAS/2018 dated 30.05.2019 has directed that till the clear findings of the Standing Medical Board GMC Srinagar are received, the appointment order of Mr. Tanveer Ahmad Sofi S/o Abdul Ahad Sofi figuring at S.No. 187 in the recommendation of PSC letter No. PSC/DR/VAS/2019 dated 05.04.2019 be put on hold.

(v). Now therefore in view of the recommendations of the J&K, PSC, dated 30.05.2019 the appointment order/posting order issued vide Government



. 59-ASH of 2019 dated 22.04.2019 and Government Order No. 71-2019 dated 03.06.2019 only in respect of Tanveer Ahmad Sofi S/o Ad Sofi figuring at S.No. 187 & S.No. 106 of above orders respectively kept in abeyance with immediate effect.


