In pursuance to selection made by Jammu & Kashmir Service Selection Board for the post of Stock Assistant (District Cadre, Ganderbal) duly endorsed by the Administrative Department vide reference quoted above, sanction is hereby accorded to the appointment of Mukesh Kumar S/o: Shri Doulat Ram R/o: Vill. Dranga P/o: Udrana Tehsil Bhadarwah District Doda as Stock Assistant under Scheduled caste category against available post at District Sheep Husbandry Organization, Ganderbal on probation basis for a period of five (05) years in the pay level-4 of Rs. 25500-81100 with immediate effect, subject to the following terms and conditions:-

- 01) The concerned Drawing and Disbursing Officer is directed to allow the joining of newly recruited candidate only after production of following requisite certificates: -
1. Academic qualification certificate/marks certificate.
 2. Date of Birth Certificate.
 3. Permanent Residential Certificate.
 4. Relevant category certificate
 5. Medical fitness certificate.
 6. No loan certificate from DIC/employment exchange.
 7. Character certificate.
- 02) The appointee shall have to give an undertaking in the shape of an affidavit to the effect that in case of any adverse report received against him with regard to prescribed qualification/DOB, character and antecedents, from police (CID), J&K; necessary action under rules shall be taken against him and he shall be liable for termination.

- 03) The appointee is directed to join at his place of posting within a period of twenty one (21) days positively from the issuance of this appointment order, failing which the Department is at liberty to cancel his appointment order under rules.
- 04) The probation bar of the appointee shall not be cleared, even if his performance is reported satisfactory by his controlling officer, till he qualify the Departmental Stock Assistant Training Course, which is the prime requirement of the post and precedence of the Department.
- 05) The salary of newly appointee shall be drawn and disbursed only after checking/verifying/authenticating all documents/qualification/category certificates and other testimonials and antecedents required under rules.
- 06) The pay of the official shall be governed according to SRO - 202 Dt: 30-06-2015
