First Appeal under RTI Act 2005 & disposal thereof.

ORDERNo. <u>937</u> SHD of 2020 Dated:- 09 -11-2020

Whereas Mr. Junaid Gaffar Bhat submitted 1st appeal under RTI Act 2005 before undersigned on grounds that he hasn't received information with respect to district Srinagar in the manner in which he has sought from Public Information Officer of this department under RTI Act 2005. Furthermore, the appellant also claims to haven't received information at all on following points sought by him:-

- Copy of permission sought by employees who have passed matriculation examination since 2010.
- Copy of sanction granted to employees by competent authority for appearing in such examination.
- Copy of leave applied for such period of examination by the employees.
- Copy of attendance register with such endorsement.
- Copy of verification done in respect of marks sheet of such employees from JKBOSE.

Whereas it was observed that appellant had sought information on following points via RTI application:-

- 1. Number of under-matric employees who passed examination since 2010.
- 2. Copies of permission sought for appearing in the matriculation examination.
- Copies of leave applied for the period of examination, copy of attendance register containing such entries.
- 14. Copies of matriculation certificate and verification report/certificate from JKBOSE.
 - 5. Number of in-service candidates promoted who have passed matriculation examination since 2010 along with copy of promotion order issued in their favour.
 - Number of employees who have passed/ completed Stock Assistant training since 2010.
 - 7. Copy of service/recruitment rule for Stock Assistant post.

Whereas the then PIO SHD Srinagar (DSHO Srinagar, now retired) had furnished information on Point No 1 and 3-7 of the application. The incumbent PIO Srinagar (DSHO Sgr) conveyed that information on Point No. 2 wasn't actually available in the office records; nonetheless, it had got erroneously mention as "enclosed" against said point.

Whereas it was observed that appellant hadn't sought via aforesaid RTI application, the copy of sanction granted to employees, who have passed matriculation examination since 2010, by competent authority for appearing in such examination; which he is claiming in his appeal to have sought from Public Information Officer earlier.

Whereas information was obtained on all points of the RTI application, in manner in which it has been sought, except point No. 2 which has been declared as "Not Available" by incumbent Public Information Officer SHD Srinagar (DSHO Srinagar).

In backdrop of above, the appeal is hereby disposed off with remarks that information on point No. 1 and 3-7 of RTI application will be provided to applicant/appellant in manner as sought by him. Moreover, PIO SHD Srinagar (DSHO Sgr) is directed to ensure that staff dealing with RTI cases remains very careful in future while furnishing information; and enclosures, if any, be properly checked before despatching.
